## PRESIDENT'S LETTER

Dear Friends,

This year the Lowell Parks & Conservation Trust marks two milestones—our 20th anniversary as an organization and the Spalding House's 250th birthday. That we have been actively preserving our natural, cultural and historical treasures for two decades is remarkable. That the Spalding House, an invaluable treasure, remains standing and accessible to remind us of our community's rich history after 25 decades is truly amazing.

While the core of our mission is to preserve open space, our organization has undertaken a variety of projects and initiatives over the years that extend our positive preservation goals and remind us of our pre-industrial history. Last year's protection of the historic Hawk Valley Farm, through a conservation restriction in cooperation with The Trustees of Reservation and Louisa Varnum, whose family originally farmed the land in the 18<sup>th</sup> century, is one example.

Coburn Park at the corner of Chelmsford and Stevens Street is another example that combines the preservation of old farmland with the refurbishment of a forgotten neighborhood park. This green space is an oasis for neighbors and passersby in a very busy area made up of residential and commercial properties. It was great to work with Mr. Alfred Coburn, a descendent of the original farm family that owned the surrounding land and with the city's Parks Department to create this unique space.

And now, with other interested parties, we're looking at what role, if any, we might play in **protecting the 1673 Jerathmell Bowers House that is currently for sale along with 3 acres of commercially zoned land along Wood Street. It is Lowell's oldest house and is on the National Register of Historic Homes.** Please see more information on this elsewhere in this issue.

These projects along with the ongoing Concord River Greenway, spring rafting, environmental education programming and upcoming outdoor winter activities (please see Calendar) are all made possible by the generosity of you, our members and by the hard work of our staff. Thank you so much for all of your support and for all that you do to make the Lowell Parks & Conservation Trust a community "treasure" as we begin our third decade.

## LOWELL'S OLDEST HOUSE AT RISK!



The Jerathmell Bowers House (c1673) sits on Wood Street, near one of Lowell's busiest intersections close to Drum Hill. You'd never know it is Lowell's oldest home - and the 18th oldest in the state. This house has been in the Bowers family since it was originally built as part of the Middlesex Village

settlement of the late 1600's. It grew to become a 150-acre farm and a garrison house, protecting settlers from the feuding Wamesit and Mohawk tribes. Until the 1950's it was sold off parcel-by-parcel until it was whittled down to the three acres it now sits on. Black Brook flows through the northern portion of the property and it abuts significant conservation land that once sited a well where the city drew its water from before it began taking drinking water from the Merrimack. Many original features of the house remain, including a beehive oven and wide-board wooden floorboards and wallboards.

The development pressure on this site is immense. The family is looking for alternatives to protect the house while also possibly developing the corner portion of the lot. LP&CT is working with the family and various agencies to increase community awareness about the threat to the home. Please call Jane at 978-934-0030 with your concerns and suggestions.

## STEWARDSHIP THROUGH LEADERSHIP



**“Wow, I never even saw a grasshopper before!”** Those are the words of joy of a boy in our environmental education program, words which tell us what a special experience it is to explore the habitats of Lowell and to witness the beauty that this city reveals upon a closer look. This past fall we presented STL at two sites through Community Teamwork Inc., at the Robinson Middle School, and at the Phoenix Avenue center. Each group explored the habitats of their respective sites through hands-on

activities learning about the interrelationships of local plants and animals. It has been remarkable to witness the youth delve into the natural environment with such curious animation. Equipped with their “critter-catching bug boxes” they enthusiastically observed up-close every insect and invertebrate they could possibly find. This was more than simply capturing critters, this was the youth capturing a connection to the land; realizing that they too play a significant role in nature. This means that we are indeed achieving our goal of exposing youth to the outdoor classroom and promoting an experience that will enrich their lives in so many ways and lead them to taking action to protect the natural environment.

## CONCORD RIVER GREENWAY NEWS

### Public Art Installed on Greenway

The Concord River Greenway is a great place to get out and explore this winter—perfect for cross-country skiing! While you're out enjoying the scenic vistas over the Concord at the Davidson section (across from the Lowell Memorial Auditorium), you'll notice two public art pieces, designed by artist Wopo Holup. As you enter the Greenway, you'll notice four new bollards, three with cast iron native birds sitting on top. The long ornamental "text" fence ahead of you includes a long quote by Henry David Thoreau. You will also find multi-lingual signage that orients you to the natural resources and history of the immediate area.

The southern end of the Greenway, near the Lowell Cemetery entrance on Lawrence Street has also seen a lot of foot traffic. There is parking available and you can enjoy a long peaceful walk (ski) along the river's bank. This spring, a granite stack will grace the gateway at this end of the Greenway, including a quote by Paul Tsongas and a carving by local artist Jay Hungate.
